This submission responds to the three key issues raised in the Ashburton Draft Solid Waste Management and Minimisation Bylaw.

This submission sets out matters of interest and concern to NPHS Te Waipounamu, and information included is based on evidence and public health and equity.

We welcome the opportunity to comment on the Ashburton Draft Solid Waste Management and Minimization Bylaw.

Health and wellbeing are influenced by a wide range of factors beyond the health sector. These factors are often referred to as the 'social determinants of health', and can be described as the environmental, economic and social conditions in which people are born, grow, live, work and age.

The diagram (see full submission) shows how these determinants of health are complex and interlinked. Initiatives to improve health outcomes and overall quality of life must involve organisations and groups beyond the health sector, such as local government, if they are to have a collective impact.

NPHS Te Waipounamu commends Council for the development and review of its Draft Solid Waste Management and Minimisation Bylaw. There are potential public health implications associated with the insanitary management of waste. It is positive that Council recognises its legislated obligations under the Waste Minimisation Act 2008. Councils have an important role to play in responding to issues related to waste management and minimisation.

A WMMP has the word minimisation in it which is not a definite line, just a recommendation. If we dont go with levels, then there will be too many holes. I think a carrot rather than a stick - reduction in inspection fees, the permission to advertise as a waste minimisation site etc.
