## Argyle Park project set to go

Construction of a new utilities building at Argyle Park to house water treatment equipment begins on 26 February, with little disruption expected for park users.

A small building will be built on the eastern side of the existing facility, which contains toilets, other water treatment equipment and storage; the new smaller, detached building will house additional UV water treatment equipment.

Group Manager for Infrastructure and Open Spaces Neil McCann said construction was expected to cause little disturbance to those who regularly used Argyle Park.

"People will still be able to use the sealed paths, the mobility car park, the sportsfields, the toilets and the playgrounds. Another good aspect of this project is that no trees will need to be removed to make way for the new building, though a couple will need to be pruned."

The work zone will be fenced off but the sealed path under the trees will still be able to be used throughout the life of the project. The mobility carpark next to the public toilets remains available, though



some other sealed parks within the work zone will be fenced off.

Mr McCann said there might be some disruption for pedestrians when the contractor was moving equipment in and out of the site, but it would be brief.

The contractor is ARC Projects and they are working to a commissioning date for the new plant in November.

The Argyle Park water treatment plant is one of four treatment plants that service

Ashburton town; there are two deep bores at the park that supply water to the plant.

Other water treatment plants for the town are at the Ashburton Domain, Bridge Street and Tinwald and these are also being upgraded in the next 10 months to have UV equipment installed.

Council is also upgrading and adding UV disinfection at water treatment plants on its smaller rural schemes, to help meet the Drinking Water Quality Assurance Rules.

## Reseals on schedule

Council's roading contractors are making good progress on rehabilitating a 1.2km section of Maronan Road, with final sealing this week.

The segment under reconstruction is between Lills Road and Lovetts Road and the project is scheduled for completion by 31 March.

Infrastructure and Open Spaces Group Manager Neil McCann said the last section to be sealed was the intersection of Maronan Road and Winslow Westerfield Road, which has been upgraded to include a right-hand turning bay for south-bound traffic.

"There are a lot of truck movements at this intersection and it's not always easy to see other road users, so it should be a lot safer."

A 1.4km section of Seafield Road, between Morris Road and the Ashburton Airport, is also being reconstructed, with the work being done in two stages.

## **Combining our SI voices**

Mayors around the South Island, including me, met recently with the new Minister for the South Island and encouraged him to keep advocating for our wider patch.

It helps that James Meager is also the MP for Rangitata and knows well some of our challenges, but was a chance for all mayors and elected members around the South Island to have their say. We had questions about the new minister's role and how it was going to work

Some also expressed dissatisfaction about a lack of Government investment in the South Island, particularly in roading – and if you look at the road user charges and petrol taxes collected, and the economic activity delivered by the South Island, we do seem to get significantly less reinvested here than what is collected.

Like many other councils, we have a fragile roading network and we're trying to get as much value out of our roading repairs and rehabilitations as possible. It's good to see our summer projects on Maronan Road and Seafield Road reach the sealing stage.

As mayors, we hope that the new Minister for the South Island advocates hard for all of us now he understands our issues and that he will make a fair case for us around the cabinet table.

Council is currently asking for feedback on a draft Climate Change & Sustainability strategy, and I encourage you to take a look, but act quickly as it closes on Sunday.

In our district, water is a key driver for the agricultural sector and technology plays an important role in balancing needs and natural resources.

Climate change is a challenge, but we have some of the smartest and most innovative farmers taking on that challenge and I back them to succeed.

It's also been a privilege this week to attend the opening of a private solar farm near Tinwald.

Council was invited along to officially celebrate the end of the construction phase and we all look forward to seeing how this new technology will add to our generation capacity.

### Are you ready for an emergency?

Mid Canterbury residents are being invited to take part in a survey that will help authorities better manage emergencies in our district.

The survey is being conducted throughout Canterbury from 17 February until 10 March and can be completed online, or by using a QR code, or by picking up a paper version from the Ashburton Library.

All responses are confidential and there is a prize draw for those who complete the survey and wish to enter. The prize is an outdoor readiness pack and there are five up for grabs.

Council Group Manager of Compliance and Development Ian Hyde said the annual preparedness survey was being conducted by Emergency Management Canterbury and would help gauge the community's awareness of potential civil defence emergencies and hazards.

"It's also designed to measure preparedness and resilience levels of residents to an emergency and get a clear idea of the emergency communication channels that community members prefer to use."

The survey takes about 10 minutes to complete and will be promoted online around Canterbury.



Questions are designed to find out how prepared households currently are and where they access trusted information.

Mr Hyde said the survey was also a great prompt for residents to think about the hazards and emergencies that might affect them

"Maybe it's time to review your own

emergency preparedness plans, because your living circumstances have changed or you have moved house.

"Being prepared is one of the most beneficial things you can do for your family."

# Help on hand for putting your bins out

Recovering from a hip operation, or health and mobility issues making things difficult getting your rubbish and recycling bins to the kerb for collection?

Call us, as Council can help.

A special bin service has been running since the introduction of the kerbside collection in 2017 and it is principally to help those who can't call on neighbours or family to assist.

Infrastructure and Open Spaces Group Manager Neil McCann said mobility issues can sometimes be the reason why residents couldn't get their red or yellow bins to the kerb on collection days.

"We see people recovering from hip or knee operations, or otherwise unable to drag their bins out. These people usually live on their own and have had health issues and been in hospital.

"All they have to do is ring Customer Services on 307 7700 and we can offer them a helping hand to get through a time when they're not so mobile"

Council staff will get in touch and arrange a time to come and do a quick assessment, to determine how regularly the bins need emptying and where the bins will be located.

Mr McCann said 14 people were currently on the list for a special collection, which was carried out by Council's contractor.

"Many people have great neighbours who help out, but some people have just moved and are not comfortable asking anyone new for help."
