Funding quest for bike facility

Detailed concept plans have been developed for a new facility in the Ashburton Domain that will help teach bike and road safety skills.

The Working Group driving the bike skills park project will use the plans when they apply to funding organisations like the Lottery Grants Board for contributions to cover the estimated \$500,000 cost of construction.

Project spokesperson Lesley Symington said resource consent had been granted for the project and the funding quest was under way.

"It's now about securing funds to make the project a reality. The concept plans have been drawn up by our landscape architect and they provide a really good visual about what we are trying to achieve.

"We'll be using the existing pump track, as well as creating a new asphalt network with road signs, and a small off-road loop through the existing trees.



"We're using the natural trees and landscape to develop an area that will be well used as people of all ages learn about riding or driving on our roads."

The area will include a railway crossing, cattle stop and solar-powered traffic lights.

Council will maintain the facility after it is built.

Staying safe: Refresher for older drivers

Finding the traffic moving a little faster these days? Or that you're not so confident behind the wheel?

A refresher course aimed at Ashburton's older drivers is all about helping you stay independent and driving for as long as possible.

The course is being run by Age Concern, and supported by Council, on 21 March, from 10am until 2pm.

Group Manager of Infrastructure and Open Spaces Neil McCann said the free course was about helping older drivers to develop strategies to remain confident on the road.

"It's important our older drivers maintain their licences, especially because there's no public transport available in the district.

"The refresher course is a theory-based session, with lots of helpful tips along the way and it covers common issues, like who gives way at roundabouts and other tricky

intersections.

"This is an opportunity for people to refamiliarise themselves with traffic rules and safe driving practices in a friendly and relaxed environment with other older drivers."

Serious food for thought

A poster in the staff lunchroom caught my eye this week – it featured comedian Josh Thomson dressed as a stalk of broccoli.

It was one of a number of eye-catching posters promoting Love Food Hate Waste's nationwide campaign to encourage Kiwis to meal plan, instead of letting food spoil in their fridges and end up in landfill.

Most households do some sort of basic meal planning, yet the average family still throws away \$1510 worth of food a year. Not only is this a waste of money, but it's bad for the environment as four per cent of our total greenhouse gasses in New Zealand come from food waste.

In fact, if food waste was a country, it would be the third largest producer of carbon emissions behind China and the United States.

We heard at Council last week about a food rescue service that operates in our district under the wing of Safer Mid Canterbury, and involves supermarkets and food wholesalers donating food that is nearing its best-by date to local foodbanks and other charity organisations.

That food is redistributed to vulnerable families, and in the past six months about 34 tonnes has been recycled in this good way.

Safer Mid Canterbury is one of the bigger agencies that Council provides operational funding to and every six months they report back to us about what they've achieved.

The funding provided by Council gives Safer Mid Canterbury a strong base to run a robust organisation that can access Central Government funding to itself run a huge range of programmes that support the people of Mid Canterbury, and many of these are based out of Community House.

Other agencies that reported back to us last week were the Ashburton Event Centre and Ashburton Performing Arts Theatre Trust, Sport Canterbury and the local Citizens Advice Bureau – these are always informative and interesting presentations, and I want to acknowledge the good work that is done by paid staff and volunteers in these organisations.

This week Councillors return to the chamber to continue their Annual Plan and budget discussions and this draft document will be refined and debated over the next months, shared with the community, and then finally adopted on 18 June.

Pudding Hill intake in spotlight

Methven community members who came along to a public meeting about the future of the Pudding Hill stockwater intake are being encouraged to take part in Council's online survey about the intake.

The survey is part of Council's work programme to exit the stockwater delivery service by 2027.

Chair of the Stockwater Transition Working Group Cr Richard Wilson said about 60 people attended the Methven meeting last week, where they could ask questions about the stockwater exit transition plan.

"Council is considering each stockwater intake separately and this meeting was for the wider community to tell us their thoughts on the Pudding Hill intake.

"There were a lot of people from Methven who were interested in keeping an amenity flow in Mt Harding Creek, which is partially fed by the Pudding Hill intake. I encourage them all to have their say via the public survey so we can capture their feedback."

The Pudding Hill intake wider community survey is open until **Tuesday 4 March**.

Property owners who pay for stockwater from the intake have already been surveyed as part of the process, and the next step involves ecological, cultural and archaeological assessments.

Cr Wilson said these assessments were being undertaken by experts and would

be taken into account when deciding the future of the intake.

"Council staff will also be investigating the role of stormwater management in relation to the stockwater network in and around Methven and that report will also feed into the final decision."

There are 17 intakes in total to be considered and the next one on the list is Methven Auxiliary. Affected property owners connected to this intake have until **Monday 3 March** to complete their survey and then the wider community will be invited to have their say mid-March.

Cr Wilson said the work programme was the same for each intake.

"First we'll survey affected property owners who pay for the stockwater from that intake, then we'll survey the wider community, then we'll get the assessments.

"It's important that people who want to be part of the process respond when it is their turn, and they can keep up to date by signing up for email updates.

"We want to make sure everyone who still needs stockwater has advice about an alternative option."

Period of closure: From **6am to 8.30am**, and from **10am to 12.30pm** on Friday 25 April.



Maronan Road line marking

Hosing ban for Methven

Council has implemented a hosing ban on the Methven and Methven Springfield water supplies from Wednesday 26 February to allow maintenance on one of the reservoirs at the Methven water treatment plant.

The water restriction means no hosing is permitted at any time during the maintenance period. Residents may water gardens by hand using a bucket or watering can. The reservoir needs to be fully drained to enable the work, which is expected to take about two weeks.
