Kia ora David,

Thank you for your response and sending through your correspondence with Amina. In principle, NZTA don't have concerns with the rezoning of the site from Residential D to Residential C, to provide for additional residential dwellings at the site. While I note that the application shows up to 12 lots, our assessment is based off the maximum number of lots that could be created within the area subject to the plan change (up to 21 lots, 360m² each).

The single access point to the State Highway is considered acceptable (subject to appropriate design). I have set out several points below for your consideration in relation to our likely design requirements:

- The proposed access location creates a staggered crossroads with Farm Road. This does not provide a sufficiently long stagger to allow safe manoeuvring to make a 'straight' through movement and safe use of the median as below. The applicant will need to maximise separation between the access and Farm Road. I assume you mean you want the road position moved further northward? That will make it very difficult to provide road connection for all lots if that is the case.
- Riverside Business Park: We have been reviewing this application which has also been lodged with the Council (resource consent). As part of this development, the applicant is proposing a series of upgrades to the Melrose/State Highway 77 intersection. Yes have set out two scenarios for you below and in relation to the design requirements for the access proposed as part of your plan change.
  - 1. If the new intersection proceeds prior to any works being undertaken at the Melrose Road/State Highway 77 intersection, the flush median layout will need to be extended, including cycle lane access to this development. Works would include paint marking, green surfacing and minor pavement widening. Noted this will require the normal works application to NZTA from an approved contractor?
  - 2. If the new intersection were to proceed after any upgrade to the Melrose Road/State Highway 77 intersection occur, tapers constructed as part of that upgrade would need to be removed from the flush median past the new intersection to this development, and the cycle lane would need to be extended to the site. Works would include paint marking, green surfacing and some minor pavement works. Noted- Its uncertain at the moment who is going to move first but I suspect it may be this proposal 259 Alford Forest Road based on the fact they will be ready to go and have far lesser road and servicing requirements.
- You have proposed inclusion of a proposed ODP which shows one access point we consider a single access to be appropriate (and the existing access to be closed), however, our comments in relation to the location of the access above may result in the location needing to be amended in the ODP. That's an issue for us as trying to enable all 12 lots to access off a road access no longer central to the development is not easy and not sure even workable. I will discuss this with the surveyor. Given that no other amendments to rule provisions are proposed, I am comfortable that the existing District Plan rules adequately manage the process in which NZTA approval would be required for the intersection, specifically the following:

10.9.9 State Highway Access (Restricted Discretionary Activity) Yes

10.7.3 Notification/Consultation/Notes

**9.7.4** Subdivision (Restricted Discretionary Activity)

I am comfortable that the existing plan provisions (namely, 10.9.9 State Highway Access) adequately provide for NZTA involvement in approving any new access to the state highway, but the above should give you some direction as to what would be required for a new access. As above

In terms of the planning process, our preference is to wait until the application is notified, to confirm that the documentation as notified is what we have reviewed and whether our feedback has been taken into consideration. I would anticipate we would then provide a submission to the application – which would reflect the points above. Ok – just allow me to explore this access matter. Which I will come back to you before any notification gets underway. I just prefer proceeding on the basis that consultation has gone as far as it can and all avenues explored.

Please let me know if you have any questions regarding any of the above, otherwise, I will await notification of the plan change by Council. Will do.
