6.1 Democracy & Engagement

• Long-Term Plan 2024-34 Consultation

On behalf of the Board, the Chair commented positively on the Methven community's involvement in the LTP consultation and the way in which the process has been executed.

• Customer Request Management

It was noted that CRM1600238/24 has not been completed and needs to be followed up by Council officers. It relates to a damaged sign at the intersection of Tactician Lane and Racecourse Avenue.

6.3 Compliance and Development

• Methven Resort consent hearing

It was reported that mediation between the parties commenced on 18 April, as scheduled. The Board will be provided with an update on a likely date for final decision.

6.4 Infrastructure & Open Spaces

• Roading

The Board asked officers to follow up on the need for trees in the dog park (Line Road) to be trimmed back. A request was also made for an update on street sweeping (to understand the extent of the township area that is swept). The Chair has observed leaves on Dolma Street and asked if this street is included.

• Methven Mall

The Board recalled discussion last year about improving access to the footpath from the Mall carpark. Officers were to investigate and report back on options to resolve the issue, particularly for wheelchair users. This will be followed up and reported back at the next meeting.

Reserves

Some minor tree work has been undertaken to remove dead branches and trees on the Methven Walkway by an arborist. The Board discussed the need for a new fence and the access issue due to the water race.

5. Activity Reports

5.1 Democracy & Engagement

5.1.1 Strategy & Policy updates

Long Term Plan 2024-34 Consultation, hearings and deliberations

The Draft ADC LTP consultation concluded on Sunday April 28. 1,522 submissions were received on the key LTP issues and policies from 1,437 individuals, 49 interest groups, 30 businesses, three lobby groups, and three Government organisations. Submissions and summary reports can be viewed at itsourplace.nz.

Council heard over 90 submitters during the week starting 13 May and deliberated for five days on the plan between 20-29 May. Final decisions made were:

- Key Decision 1 Green waste Council approved the introduction of a greenwaste kerbside collection service for residential users
- Key Decision 2 Water leisure Council decided not to progress any projects at this time and removed this funding from the budget
- Key Decision 3 Balmoral Hall/Old Polytech land Council decided to retain the hall for two years or until it becomes unusable and demolish or relocated buildings from the old Polytech land and construct a carpark
- Key Decision 4 Stockwater Council decided to exit the stockwater service by 30 June with a project group to be set up to provide governance for the project
- Key Decision 5 EA Networks Stadium extension Council agreed to the three court extension, but moved this out to Years 7-9 of the LTP.

Other decisions of note for Methven were:

- \$25,000 annual funding for the Methven swimming pool
- No funding for the Methven Birdsong Initiative
- \$116,000 capital funding (years 1-4) and \$5,000 annual operational funding for the Methven lighting project
- \$75,000 in year 2 to investigate alternative sites for the Methven Recovery Park
- Methven Strategic Plan funding (\$20,000) to be funded through the UAGC, rather than the Methven targeted rate
- Reduction in funding (\$20,000) for the Methven reserve board mowing costs
- Reduction in funding (\$20,000) for the Mt Hut Memorial Hall salaries
- \$25,000 for investigation of a district biking trail
- Additional funding of \$500,000 annually for unsubsidised roading for maintaining the unsealed roading network

Representation Review

The Representation Review Initial Proposal was adopted by Council on 5 June, with consultation planned for 13 June to 21 July. This includes the proposal to extend the Methven Community Board boundary and reduce the number of elected members to 4 from 5 (total membership of the 6 including 2 appointed members). A small boundary change is proposed for the Ashburton ward, but no other changes to current representation arrangements.

Draft Reserve Management Plans

- Reserve Management Plans the Reserve classifications consultation closed 1 June with no submissions received. This will now be formalised.
- The draft Reserve Management Plans have been approved for consultation. This two month consultation (under the Reserves Act) opened 4 June and closed 4 August. Consultation material can be found here <u>Love Your Parks</u>

ADC Submissions

A submission from ADC has recently been made on the ECan Representation Review.

Solid Waste Bylaw review

Work is progressing on the Solid Waste Bylaw review, with consultation planned for later this year.

• Government update

The government have released two significant Bills, including the second bill for **Local Water Done Well**, the replacement for the previous Labour government's Affordable Water Reforms. This will require councils to develop a service delivery plan for three waters (water supply, wastewater and stormwater) within one year of enactment.

Secondly, the first tranche of changes to the Resource Management Act, which focus on changes to the National Policy Statement for freshwater management, low slope map and associated requirement for stock exclusion, winter grazing requirements and changes to SNA requirement under the National Policy Statement for indigenous biodiversity. If passed, this would become law by the end of 2024.

5.2.1 Finance Report

5.2.2 Customer Request Management

The CRM report continues to focus on requests for service relating to roading, footpaths and water issues. Other activities subject to service requests (for example waste bin replacements), will be reported if there has been a significant issue.

5.3.1 Building Services

The table shows sixteen consents that have been issued, ten of which have been new housing. The drop in consents and housing is less significant at 20% than the rest of the District which is about 33%.

5.3.2 Economic Development

• Rural Banking Trial

Reserve Bank of New Zealand has undertaken work to explore cash use in rural communities, specifically, the community's access to cash and for businesses having an ability to deposit cash and not have to retain large amounts of cash on their premises overnight.

The Economic Development Team will be working with the Methven Community Board to apply to be part of the national trial of 6-8 towns who will have a 'white label' banking system installed in the town.

If successful the trial will run for around 18 months with a research element running alongside the trial.


5.4 Infrastructure & Open Spaces

5.4.1 Roading

The Methven Mall footpath access has been assessed by staff. This was initially for general pedestrian access but the need for additional mobility access was requested. Additional cutdowns could be made in the kerb and channel approximately half way through the Mall. These will require the removal of a parking space each side and should also have mobility parks added. It would be appropriate to meet with MCB members on site to discuss this.

The trees on the boundary of the dog park on Line Rd are maintained by Open Spaces. They do encroach into the road reserve but caused no issues for the new footpath construction. Officers can discuss with trimming them back with the Open Spaces team.

All of the kerb and channel in Methven has street cleaning carried out. The map below shows the weekly cleaning. All other roads are eight weekly.



5.4.2 Open Spaces

Reserves

Staff are currently committed to undertaking winter maintenance around Methven. This includes ongoing leaf clean-up, winter pruning of trees and shrubberies, mulching and composting as required. The annual bedding in the central business district has been replaced and the plants are growing on well. Staff have also underplanted tulip bulbs underneath the annuals to add another dimension of colour to the spring display. General maintenance tasks on these gardens are continuing on a cyclical basis. Additional daffodils have been added in various locations for Spring colour.

The new Natalie Currie Park in Camrose Estate, fronting Holmes Road, is still under construction. Topsoiling and re-grassing of the park and re-contouring of the mounds will be completed in conjunction with Stage 14 (Grace Ireland Drive) of this development at Camrose Estate.

Mowing activities are continuing but on a less frequent timeline driven by current growth conditions.

RDR Pipe – a consulting structural engineer has drawn up detailed remediation plans which will be implemented once approved by RDR management.

Playground inspections and maintenance continues on a cyclical weekly basis. There was a leak on the Railway reserve site, which has been fixed but will require further surface reinstatement works.

• Methven Cemetery

General maintenance continues to be delivered at the cemetery and weed control and spraying is ongoing. Mowing activities are in alignment with other town lawns – on a reducing schedule.

The Methven Lions have completed planting of the bund on the eastern side of the cemetery. This work now completes the collaborative planting project adjacent to the walkway which is a real success.

The only other planting yet to occur is adjacent to the water race on the northern cemetery boundary. This will happen as soon as the plants are delivered.

• Public toilets

These are functioning well. There has been a recent issue with local youth accessing the ceiling space. Staff have rectified this situation, further securing the ceiling panels and reinstating the subsequent resulting damage.

• CBD seats

Snowfed Builders will be undertaking renovation work on the Methven CBD seats. Five seats will be removed initially and, once renovated, will be reinstalled before the next seats are removed and upgraded.
