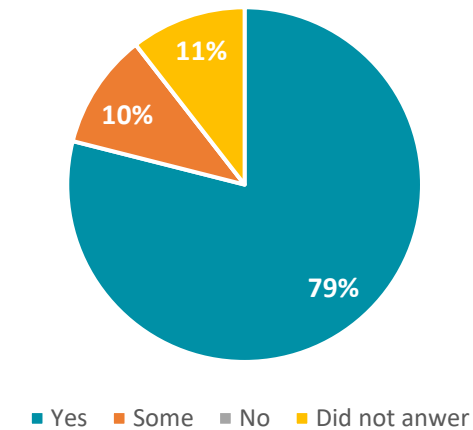

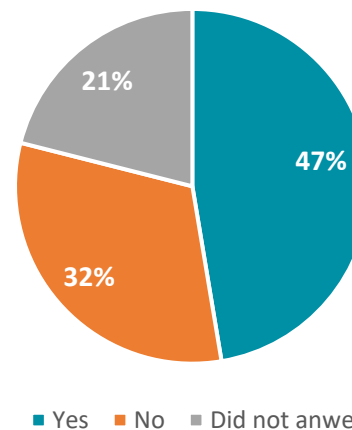

Submitter notes where the resource consent process to expand their holiday park took longer and delayed expansion plan.</p> <p>Suggests having a business growth team at ADC that existing businesses can work alongside to make compliance easier and support business growth. All this will help increase tourism and region’s attractiveness.
